**OFFICE MEMORANDUM**

**SUBJECT:** Circulation of draft Seniority List of Personal Assistants of CSSS Cadre of Ministry of Law and Justice as on 24.05.2017 – reg.

The undersigned is directed to circulate herewith draft Seniority List of Personal Assistants of the CSSS Cadre of Ministry of Law and Justice (Department of Legal Affairs and Legislative Department) as on 24.05.2017.

2. As per provisions of CSSS Rules, 1969 and CSSS Rules, 2010, the interpolation of Personal belonging to Seniority Quota along with the merit list of LDCE quota is in the ratio of 1:1 i.e. 50% SQ and 50% LDCE.

3. The interpolation of Personal Assistants upto SL Year 2012 in the draft Seniority List is as per CSL issued by DoP&T, vide O.M. No.4/11/2014-CS.II(A) dated 11.12.2015. There is no PA belonging to SL Year 2013 and 2014 in CSSS Cadre of this Ministry. Two PAs of subsequent Select List Years, one belonging to SL Year 2015 and one of SL Year 2016 have been interpolated in the order of their seniority. However, their interpolation is provisional and is subject to issuance of final CSL of PAs of these Select List Years.

4. All the concerned are requested to go through the draft Seniority List and submit representation/objections, if any with regard to any factual inaccuracy (not interpolation) in the list to the undersigned, within 30 days of the issuance of this O.M.
