OFFICE MEMORANDUM

SUBJECT: Circulation of draft Seniority List of Private Secretaries of CSSS Cadre of Ministry of Law and Justice as on 30.05.2017 – reg.

The undersigned is directed to circulate herewith draft Seniority List of Private Secretaries of the CSSS Cadre of Ministry of Law and Justice (Department of Legal Affairs and Legislative Department) as on 30.05.2017.

2. As per provisions of CSSS Rules, 1969 (which remained effective till Select List Year 2009), the interpolation of Private Secretaries belonging to Seniority Quota along with the merit list of LDCE quota is in the ratio of 1:1 i.e. 50% SQ and 50% LDCE. As per CSSS Rules, 2010 (which are effective from Select List Year 2010 onwards), the interpolation of PS of SQ along with the merit list of LDCE quota is in the ratio of 2:1 i.e. 66.67% SQ and 33.33% LDCE.

3. The interpolation of Private Secretaries upto SL Year 2011 in the draft Seniority List is as per CSL issued by DoP&T, vide O.M. No.3/9/2014-CS.II(A) dated 31.08.2015. The interpolation of the Private Secretaries from SL Year 2012 onwards is provisional and is subject to revision on issuance of final CSL of these Select List Years by DoP&T.

4. All the concerned are requested to go through the draft Seniority List and submit representation/objections, if any with regard to any factual inaccuracy (not interpolation) in the list to the undersigned, within 15 days of the issuance of this O.M.
