 - a. He/ she is neither a Notary already appointed by any State Government nor his/ her application for appointment as notary is pending with the concerned State Government.
 - b. No criminal case/disciplinary proceedings are pending or initiated against him/ her by any Court of Law or by Bar Council concerned as on date.
 - c. He/ she is not an undischarged insolvent, and
 - d. He/ she has not been convicted by any Court of Law for an offence involving moral turpitude.
