Notary Cell, Department of Legal Affairs, Ministry of Law and Justice had conducted interviews for appointment as notaries **for the UT of Puducherry from 16<sup>th</sup> & 17<sup>th</sup> July, 2022.**

2. The Candidates were assessed keeping in view their competency, legal knowledge and other relevant factors related to the selection as per requirements of the Notaries Act, 1952, the Notaries Rules, 1956 and the relevant guidelines by the Interview Board constituted for the purpose by the Central Government. On the basis of the performance of the candidates before the Interview Board, the Interview Board has recommended names of the following candidates as notaries for the UT of Puducherry **as per PDF attached.**

3. A Certificate of Practice will be issued to all the successful candidates (whose names appear in the PDF attached) after submission of following documents:-

- (i) Receipt of payment of rupees two thousand rupees only (Rs. 2000/-) through Bharat Kosh Portal (<https://bharatkosh.gov.in>);
- (ii) Self-attested photo copy of High School/ X Class Certificate;
- (iii) Self-attested photo copy of LL.B. Degree;
- (iv) Self-attested photo copy of enrollment Certificate as an Advocate;
- (v) **Original No Objection Certificate (NOC) for appointment of Central public Notary from Concerned Bar Council;**
- (vi) Self-attested photo copy of Aadhar Card;
- (vii) Self-attested photo copy of Caste/ Disability Certificate (if applicable);
- (viii) Two passport size color photographs;
- (ix) Candidate Full name, father's name and correct address (with pin code) in Hindi and English on a white plain paper;
- (x) An affidavit duly attested by 1<sup>st</sup> Class Magistrate deposing the following points:-

- You are neither a Notary already appointed by any State Government nor your application for appointment as notary is pending with the concerned State/ UT Government.
- No criminal case/disciplinary proceedings are pending or initiated against you by any Court of Law or by Bar Council concerned as on date.
- You are not an undischarged insolvent, and
- You have not been convicted by any Court of Law for an offence involving moral turpitude.

**Note:- All successful candidates as per the PDF list attached are required to obtain No Objection Certificate (NOC) from the concerned State/ UT Bar Council. No Individual intimation in this regard shall be given to the candidates.**
