**OFFICE MEMORANDUM**

**SUBJECT:** Circulation of draft Seniority List of Assistant Section Officers (erstwhile Assistants) of CSS Cadre of Ministry of Law and Justice as on 01.03.2017 – reg.

The undersigned is directed to circulate herewith draft Seniority List of Assistant Section Officers (erstwhile Assistants) of the CSS Cadre of Ministry of Law and Justice (Department of Legal Affairs and Legislative Department) as on 01.03.2017.

2. As per provisions of CSS Rules, 1962, the interpolation of Assistant Section Officers (erstwhile Assistants) belonging to Seniority Quota along with the merit list of Direct Recruitment quota is in the ratio of 1:1. As per CSS Rules, 2009, the interpolation of ASO of SQ along with the merit list of DR quota is in the ratio of 1:3.
3. The interpolation of ASOs for SL Year 2003 in the draft Seniority List is as per revised Final Common Seniority List of Assistants of CSS issued by DoP&T, vide O.M. No.7/4/2010-CS.I(A) dated 12.07.2012. The interpolation of ASOs for SL Years 2004-2008 is as per draft revised CSL of ASOs of CSS issued by DoP&T, vide O.M. No.7/1/2009-CS.I(A) dated 15.03.2016 and is subject to revision on issuance of final CSL of these Select List Years by DoP&T. The interpolation of remaining regular ASOs is also provisional and is subject to change on issuance of CSL by DOP&T.
4. The interpolation of ad-hoc ASOs [regular SSAs of SL-2003 (extended)] in the draft Seniority List is as per final CSL of SSAs of SL-2003 (extended) issued by DoP&T, vide O.M. No.12/5/2015-CS.II(B) dated 02.11.2015.
5. The interpolation of regular ASOs from SL-2004 onwards and in respect of ad-hoc ASOs would be subject to outcome of various court cases mentioned in DoP&T's O.M. dated 15.03.2016 and 02.11.2015 respectively and also any other order by any Competent Court in any of the connected matters apart from the Court Cases mentioned in above two O.M.
6. All the concerned are requested to go through the draft Seniority List and submit representation/objections, if any with regard to any factual inaccuracy (not interpolation) in the list to the undersigned, within 30 days of the issuance of this O.M.


