The Appellant-Applicant filed an RTI application dated 16.12.2014 (received on 23.12.2014) seeking information on 6 points and the Respondent-CPIO, vide, his letter dated 26.12.2014 furnished the information sought by the Appellant-Applicant. Aggrieved by the information supplied by the Respondent-CPIO, he preferred the present appeal dated 10.02.2015 put up to me with comments on 05.03.2015.

2. I have gone through Appeal memo, comments of CPIO on the appeal as well as information furnished by the CPIO and thereafter I am of the view that, since the information sought in RTI application of the Appellant-Applicant pertains to Ministry of Labour hence was transferred, the Appellant ought to have pursued his RTI application with the CPIO, Ministry of Labour. In view of this, I see no merit in the present appeal. However, the Appellant Applicant may like to pursue his RTI application directly with CPIO, Ministry of Labour, Shram Shakti Bhavan, Rafi Marg, New Delhi-110001.

3. Appeal dismissed.
