
ORDER

3. Being aggrieved with the information of the respondent the appellant has filed

4. I undersigned have been appointed as Appellate Authority in the matter on. After perusal of the facts of the case it appears that no hearing is required in this matter.

Observation

- On perusal of the record it appears that the information furnished by the respondent vide letter dated 06.02.2013 is the substantive response for the information asked by the applicant in the original application.
