Invitation for Submission of Offer/Quotation for Website Accessibility Audit of Department's website (<https://legalaffairs.gov.in> & <https://lawmin.gov.in>)

1. Background:

- a) An accessibility audit is a thorough, professional evaluation of how well a website, mobile application or any other digital system meet the needs of people with disabilities, conform with the Web Content Accessibility Guidelines (WCAG), and comply with legal standards such as Rule 15, sub-rule (1), clause (c), item (i) and (iii) as amended vide MSJE Notification No. G.S.R.359(E) dated 10 May, 2023 and comply with the Indian standards IS-17802 (Part 1), 2021 and IS-17802 (Part 2), 2022, published by the Bureau of Indian Standards vide notification numbers HQ-PUB0131112020-PUB- BIS(278), dated the 24th December, 2021 and HQ-PUB0131112020-PUB-BIS(358), dated the 4th May, 2022, respectively as amended from time to time.
- b) For compliance with the above, establishments shall get their websites/apps audited for digital accessibility compliance by an accessibility expert **who holds certification from International Association of Accessibility Professionals (IAAP)**, and the government establishments are required to submit STQC certification to the Court of the Chief Commissioner for Persons with Disabilities (DIVYANGJAN).

2. Scope of Work: The auditor will assess various accessibility aspects as per WCAG accessibility standards and guidelines as notified under Rule 15 of the Rights of Persons with Disabilities (RPWD) Rules, specifically IS 17802 – Accessibility for ICT Products and Services, and WCAG 2.2 Level AA, including but not limited to:

- a) Design and ease of navigation using keyboard, screen readers, and other assistive technologies
- b) Usage of visual indicators
- c) Contrast, colour and font compliance
- d) Availability of text alternatives for images for screen readers
- e) Compatibility with assistive technologies
- f) Accessibility of interactive elements (forms, buttons, etc.)
- g) Error identification and clear instructions for users.

3. Test Environments:

- a) Operating System: Windows 11
- b) Browser: Chrome/Firefox/Edge
- c) Assistive Technology: NVDA (screen reader)

4. Timeline:

5. Blacklisting: Auditors failing to meet the stipulated timelines or refused to undertake the work, run the risk of being blacklisted by the department and further action may be taken by DePWD as the terms and conditions of the empanelment.

6. **Eligibility:** Web Accessibility Auditors empanelled with Department of Empowerment of Persons with Disabilities, Ministry of Social Justice & Empowerment, Govt, of India are allowed to participate in this proposal.

7. **Payment Term:** Payment will be released on completion of the Accessibility Audit of the website.

8. **Last date and Time of submission:** 16.05.2025 by 05:00 P.M.

9. **Offer/Quotation Submission:**

- a) Auditors are requested to submit offer/quotations for the defined scope of work and deliverables. The consolidated cost should be provided for the following two stages of testing:
 - First detailed testing leading to the audit report; and
 - Retesting cum Final Compliance after the site is remediated by the Department's development team.
- b) The role of the auditor is limited to the audit, and all remediation work will be undertaken by the Ministry/Department.

10. **Mode of Submission:**

Only DePWD empanelled Web Accessibility Auditors are required to submit offer/quotation in the format given as **Annexure-I** along with the Agencies profile (As per format given in **Annexure-II**) to the following address through physical mode (agencies may intimate the under-mentioned after sending the document through post) but the same shall reach before last date and time of submission:

11. **Penalties:**

2 . It may be noted that the aforementioned empaneled auditors may be chosen by the concerned Departments/Organisations/end-users for their work/tasks as per their own discretion and responsibility. All the specific terms and conditions regarding hiring of the empaneled auditors, assignment of work/tasks, etc. are to be worked out between the service seekers and service providers as per the extant law in force and other mandatory provisions.

3. The empanelment is subject to the following terms and conditions:-

I Scope of Work:

The empaneled access auditors in the web accessibility with the Department of Empowerment of Persons with Disabilities (DEPwD) shall have the responsibility to assess and evaluate the accessibility of web applications for persons with disabilities. The scope of work for empaneled access auditors includes:

- Accessibility audits of websites, including but not limited to their

designing, ease of navigation, usage of visual indicators, contrast and color, availability of text alternatives for image for screen readers etc. to ensure compliance with accessibility standards and guidelines notified under Rule 15 of the RPwD Rules.

ii. Documenting and reporting on the status of accessibility features on various web applications.

iii. Providing detailed reports highlighting areas of non-compliance and suggesting corrective measures

iv. Jointly with DEPwD conduct training sessions or workshops for stakeholders involved in design, construction and maintenance of web applications to raise awareness about accessibility requirements.

v. Monitoring and evaluating the implementation of recommended measures to ensure that they are effectively incorporated and continue to meet web accessibility standards.

vi. Staying updated on changes in web accessibility standards and regulations through continuous professional development.

It is important for empaneled access auditors to work closely with the DEPwD and other relevant stakeholders to contribute to the creation of more inclusive and accessible environment for PwDs. The scope of work may vary based on the specific needs and priorities outlined by the Department and the applicable legal framework.

II Discretion of DEPwD

DEPwD, in its sole discretion and without incurring any obligation or liability, reserves the right at any time to cancel the empanelment of the organization/individuals as web accessibility auditors if the work and information submitted found unsatisfactory.
