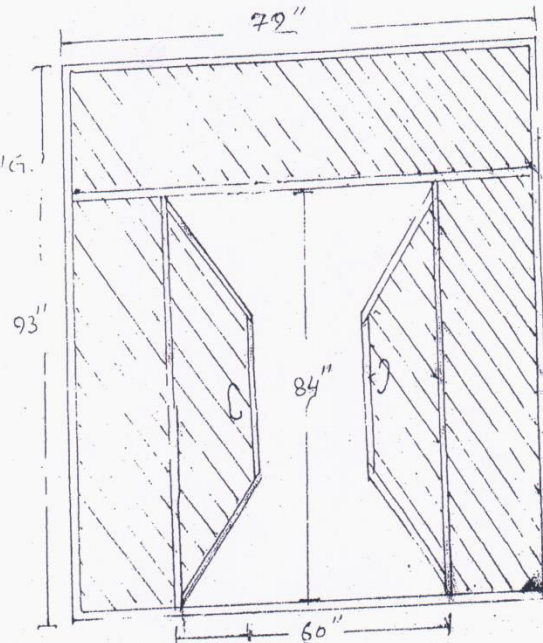
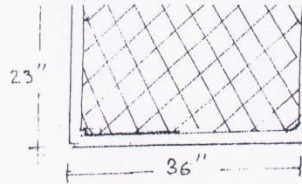

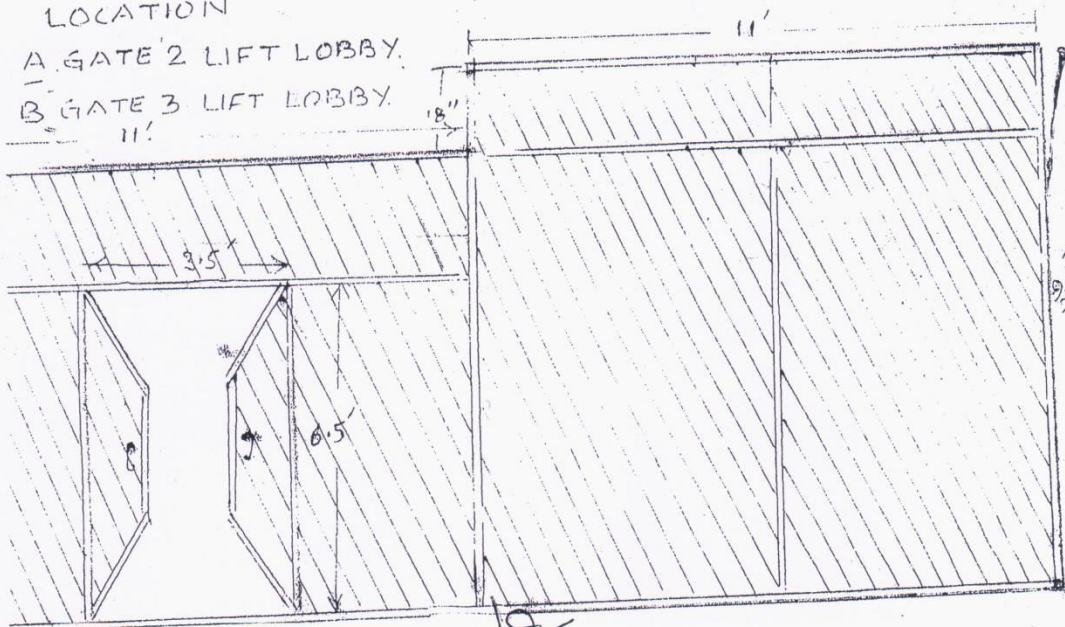


3. STAIRS FENCING WITH DOOR - 2 NOS

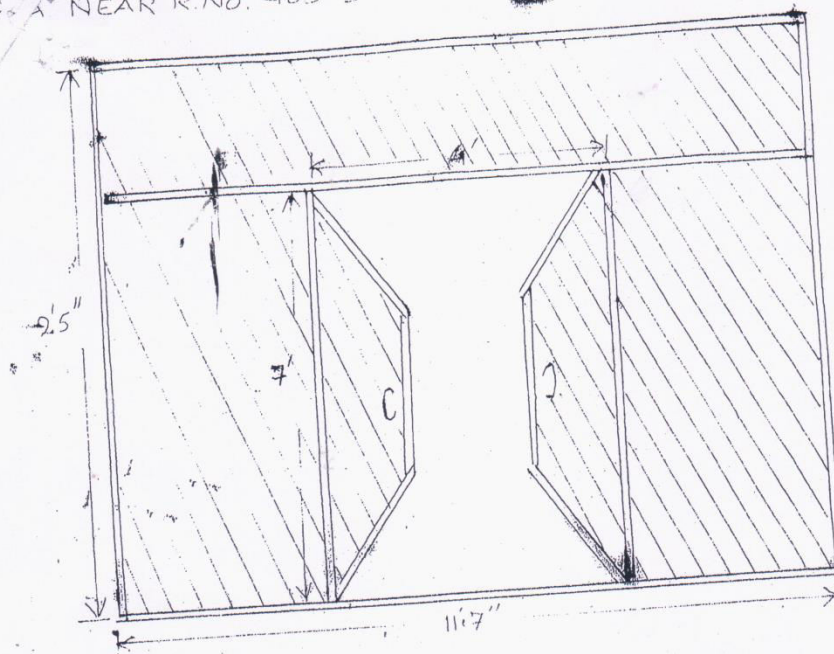


AIRS FENCING WITH DOOR

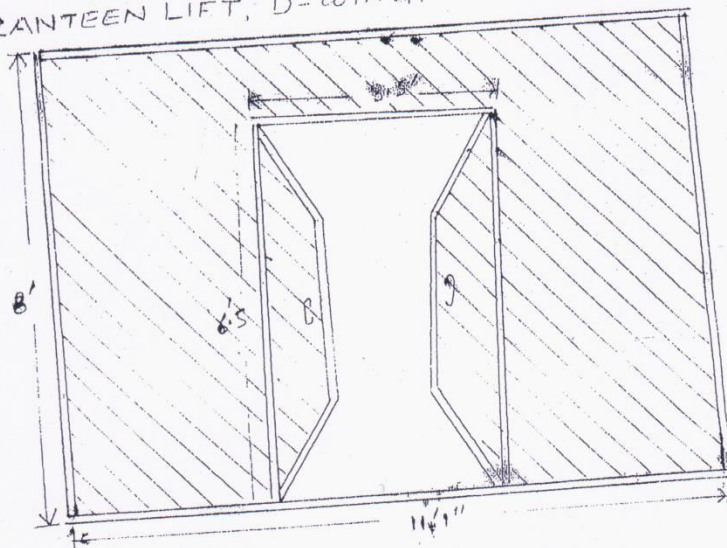

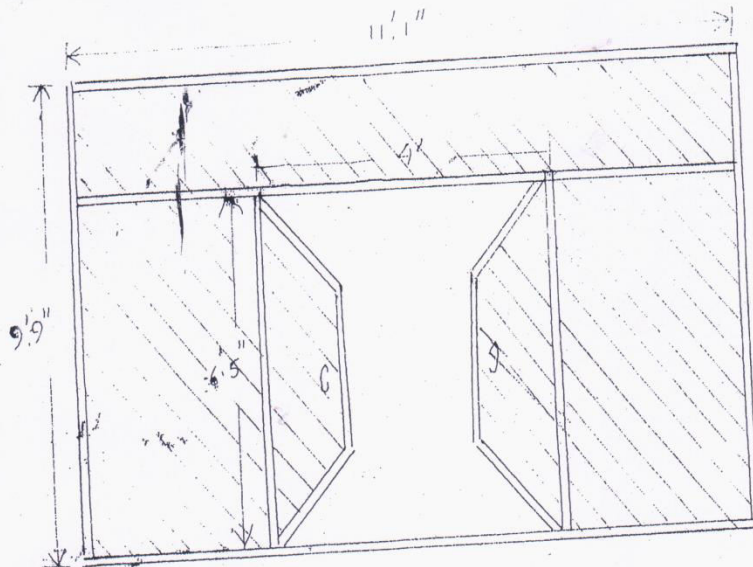
